Professional qualifications: I qualified MB ChB at Edinburgh University in 1996. I was elected a fellow of the Royal College of Anaesthetists (FRCA) in 2003 having passed the required examinations. I was granted Fellowship of the Faculty of Pain Medicine of the Royal College of Anaesthetists in 2008. During training I also completed a postgraduate diploma in Medical Science/Anaesthesia (with merit) in 2007.

NHS Consultant appointments: I was appointed as a Consultant in Anaesthetics and Pain Management at East Kent Hospitals University NHS Foundation Trust at Margate and Canterbury in August 2009. At the end of 2014, I gave up my anaesthetics commitments based on my decision to become a dedicated pain management specialist.

NHS practice: My NHS duties include the management of chronic pain at the Kent Centre for Pain Medicine. The NHS service is interdisciplinary / multidisciplinary combining the services of medical consultants, specialist nurses, clinical psychologists & occupational therapists. He was one of the originators of the neuromodulation (intrathecal drug delivery and spinal cord stimulation) service in East Kent.

I have extensive experience in the management of a wide range of painful conditions including those that can result from personal injury. This experience includes clinical problems such as complex regional pain syndrome (CRPS), chronic pain syndromes, neuropathic pain, *lumbar* spinal pain & sciatica; thoracic spinal pain; cervical spinal pain & whiplash; shoulder, hip and knee pain; chronic pelvic pain and chronic pain after surgery & trauma.

Specialist medical interests: My interventional experience includes a range of injections, radiofrequency techniques, intrathecal drug delivery (ITDD) and spinal cord stimulation (SCS).

Educational & training roles: I have been involved in teaching and training at all levels from teaching ECG techniques to nurses through to teaching pain medicine and testing clinical skills for medical students to being involved in lecturing for the Primary FRCA course and viva practice at both Primary and Final FRCA level. I have regularly instructed on local Advanced Trauma and Life Support courses. I have previously organised meetings of the Interventional Pain Management Special Interest Group of the British Pain Society.

I have presented at The British Pain Society meetings, the Anaesthetic Research Society, the British Trauma Society and the World Congress of Pain, and I have critically reviewed articles for publication in the journals *Pain Medicine*, *British Journal of Pain* and am Associate Editor of the *Journal of Observational Pain Medicine*.

Medicolegal training, practice and experience:

Medicolegal training: I attended the Bond Solon ‘Excellence in Report Writing’ course in 2010, and completed the Bond Solon ‘Civil Procedure Rules for Expert Witnesses Certificate’ in 2013. I regularly attend the Cambridge Medicolegal conference and Pain Expert conference to ensure current legal requirements for Medicolegal reports are met and also ensure on-going training and compliance

Medicolegal report writing experience: I have been preparing expert evidence for the Court in matters of personal injury and medical negligence for over 12 years. I currently examine between twenty to thirty claimants per year. The reports I compose most commonly relate to complex cases with symptoms of chronic pain persisting beyond the expected healing period associated with much more disability than might be expected.

Courtroom experience and provision of oral evidence: I have not, as yet, been required to attend Court in the United Kingdom.

Membership of expert witness organisations: I am listed on the UK Register of Expert Witnesses.
